If you're unfamiliar with sporting clays ... to put it in a “shot shell” ... Sporting Clays, sometimes referred to as “Golf with a Shotgun” consists of a series of natural and unique shooting fields connected along a course trail. At each field (or station), participants attempt to shot airborne clay targets simulating gamebird wingshooting (and even a couple of bouncing “rabbit” targets!

As teams of 5 people tour the course, they each take turns shooting at a set of targets. Scoring is easy ... each target equals one point and the shooter with the most points wins.
